**Referral Rebate:** Regardless of your child's tuition, you may receive either a **\$100 Referral Rebate** check or a \$100 credit toward camp 2019 (only) for any families you refer (one rebate per family for new families referred who have never attended any Red Robin programs in the past) once that family has made their tuition payment in full. Referred family must present the referral rebate certificate at the time of registration.

Conditions of Enrollment:

- Appropriate deposit based on tuition chosen (see tuition form) with completed, signed registration and consent/transportation forms constitute registration.
- Camp tuition includes transportation, hot and cold lunches, snacks, a camp t-shirt, a camp backpack and fresh daily towel service.
- Full refunds, less a \$295 withdrawal fee, will be made up until April 1, 2019. Withdrawals must be made in writing prior to this date. After April 1, 2019, the full deposit payment will be forfeited.
- In the event a camp day is cancelled due to an act of nature or any other cause beyond Red Robin Camp's control, we regret that no refunds or make-up days will be provided. Additionally, in the event that your child does not successfully adjust to camp during the 2019 summer season, as agreed between your family and Red Robin Camp's Directors, Red Robin will refund the remainder of the tuition for the 2019 camp season, less a prorated mandatory 10 day adjustment period based on your child's camp tuition. After 10 days of attendance, camp tuition per day will be prorated accordingly. Please understand that those families who withdraw after the start of camp for any other reason will receive no refunds. Please note that Red Robin Camp reserves the right to cancel this contract in the event of a delinquent payment, as determined by the Directors, and I agree to pay all legal and collection company fees incurred during any collection process. In addition, I agree to pay Red Robin a \$25.00 service charge for any and all checks returned from my bank for non-payments.
- A complete medical examination record of immunizations and documented health history (must have been completed after August 21, 2018) are required to be submitted prior to attending camp.
- I give permission for my child to participate in all of Red Robin Camp's programs, activities, and special events, without exception. Furthermore, I understand that my child will participate in camp activities involving running, jumping, climbing, ball playing, swimming and other recreational sports and physical activities. I understand and acknowledge that these activities carry some risk of physical injury to my child.
- Consent is given to Red Robin to use photos and/or videos of my child for promotion of Red Robin Country Day Camp and its programs.
- Permission is given for my child, in case of an emergency when neither a parent nor family physician can be reached, to be treated in the emergency room of a local hospital or at a physician's office.
- I agree to allow my child to be transported on Red Robin's owned and/or leased buses.
